ORDER:-

In the G.O. 5th cited read with Gazettee 4th cited, the Government of Telangana enhanced the age of superannuation of the State Government employees of the Telangana State, from 58 /60 years to 61 years.

2. In the Circular Memo 7th cited, the Government of Telangana instructed all the Grant-in-Aid Institutions, Societies, Universities (in respect of non-teaching staff), Corporations, Institutions and other Organisations may take necessary action to adopt the age of superannuation as enhanced for the State Government Employees, for their employees also from the date of amendment to the Telangana Act No.3 of 2021 come into force i.e., from 30th March, 2021, duly obtaining the approval / ratification of the competent authority and amending the relevant service rules of their respective organisations.

3. In Letter 9th cited, the Government of Telangana, Energy Department instructed to take necessary action in accordance with the instructions issued Circular Memo 7th cited in respect of the employees working in TS Power Utilities towards enhancing the age of superannuation from 58/60 years to 61 years.

4. After careful examination, TSTRANSCO hereby directs that:-

- i. The age of retirement of all the employees of the Corporation who are Other than Workmen (Class I and II) shall be raised from 58 years to 61 years.
- ii. The age of retirement of the office staff of the Corporation (Class-III), who are categorised as Workmen shall be raised from 58 years to 61 years.
- iii. The age of retirement of the General Service Employees (Class-IV) shall be raised from 60 years to 61 years.
- iv. The employees who have retired after 30-3-2021 shall report for duty within two (2) days from the date of issuance of these orders to their appointing authorities for issuing reposting orders and the period from the date of re-induction to date of reporting on issuance of posting is eligible for compulsory wait.

- v. The employees who have re-inducted into service shall be protected all the service benefits including seniority, which he/she was entitled earlier.
 - vi. The employees who have retired after 30-03-2021 shall have to remit all the terminal benefits released/paid to them i.e., before re-induction into service, delay in remittance of released/paid terminal benefits shall attracts interest @ 9% per annum from the date of release /paid of terminal benefits.
 - vii. The period of absence of the employees who have retired after 30-3-2021 and to the date of re-induction into service (i.e., Two (2) days from the date of issuance of these orders) shall be treated as "ON DUTY" and they shall be extended all the Service Benefits flowing out of Service Regulations / Orders, failing which the period from 01-04-2021 to the date of re-induction into service shall be treated as Leave and they shall be sanctioned eligible leave at their credit.
5. The above orders shall come into effect from 30-03-2021.
 6. These orders shall not apply in respect of the employees in the following categories:
 - a. Employees, who have retired on superannuation prior to 30-03-2021.
 - b. Those employed on contract basis.
 7. Necessary amendments to the relevant rules shall be issued separately.
 8. These orders are issued with the concurrence of the Jt.Managing Director (Fin., Comml., & HRD) vide Regd.No.1624 dt.12-04-2021.
