ORDER:

Representations have been received from certain Assistant
Engineers / Junior Accounts Officers recruited in 2009 & 2010 seeking
permanent absorption of their services from APTRANSCO to TSTRANSCO.

2. After careful examination, TSTRANSCO has taken a decision to absorb
zonal direct recruitees AEs/JAOs Local to Telangana, as mentioned in the
annexure appended to these orders, who are selected against open vacancies of
Vizag, Vijayawada and Kadapa during 2009 & 2010 recruitments, working in
TSTRANSCO and to include their names below the junior-most AE/JAO of
TSTRANSCO of that batch.

3. The absorption of the services of AEs / JAOs from APTRANSCO to
TSTRANSCO is subject to the following conditions:

- The absorption of the employee is considered at their request only.
- The absorption once permitted is irrevocable.
- Accepts last rank in the seniority below the junior-most AE/JAO of
TSTRANSCO of that batch.
- The employees forfeit their lien and seniority on a permanent or
officiating post in the category or grade in the class of the service of
APTRANSCO to which they belong.
- The employees have to work anywhere in TSTRANSCO.
- They shall be treated to be on the rolls of TSTRANSCO.
- They shall governed by the Rules and Regulations of TSTRANSCO.
- The said employees shall abide by the undertaking given by them.

4. They are directed to report to CGM (HRD)/JS/TRANSCO for obtaining
reposting orders.
