**ORDER:**

In the reference 2<sup>nd</sup> cited, orders were issued indicating General/Major & SFMS ceilings & contribution for the treatment of Employees/Pensioners and Family Pensioners.

2. In the Memorandum of Settlement dt.19-04-2023 at para-14(e) it is agreed for enhancement of General/Major/SFMS Ceilings and contribution towards SFMS for the treatment of Employees/Pensioners and Family Pensioners as follows:

Sl. No.	Existing General/Major/SFMS Ceilings	Enhanced Ceilings as per Memorandum of Settlement dt.19-04-2023
1.	The maximum General Ceiling limit is enhanced to Rs.5.0 lakhs per family is fixed for all the minor ailments/diseases for life time for Employees/ Pensioners/Family Pensioners and their dependents	The maximum General Ceiling limit is enhanced to Rs.10.0 lakhs per family is fixed for all the minor ailments/diseases for life time for Employees/Pensioners and their dependents & family pensioners.
2.	The maximum ceiling limit of Major ailments is enhanced to Rs.12.0 lakhs for life time @ Rs.4.0 lakhs each time in three spells for each ailment separately for Major ailments/surgeries/treatments i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic Valve Replacement, PTCA Stent, Three spells means three surgeries for same ailment.	The maximum ceiling limit of major ailments/diseases is enhanced to Rs.15.0 lakhs for life time @ Rs.5.0 lakhs each time i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic Valve Replacement, PTCA Stent.

3.	The Self Funding Medical Scheme is enhanced to Rs.6.0 lakhs per family per year over and above the Minor Ceiling and Major Ceiling as per the CGHS/NIMS tariff rates and enhanced the monthly contribution from Rs.100/- per month to Rs.500/- per month from Employees/Pensioners, Family Pensioners. It will be reviewed every 6 months	The Self Funding Medical Scheme is enhanced to Rs.12.0 lakhs per family for every financial year by enhancing the Employees/Pensioners and Family Pensioners contribution from Rs.500/- per month to Rs.1000/- per month. It will be reviewed every 6 months.
4.	Dental: Rs.10,000/- each time (three times in life time)	Enhanced to Rs.50,000/- each time (three times in life time) and above Rs.50,000/- will be reimbursed from SFMS.
5.	Eye: Rs.14,000/- each time (Three times in life time)	Enhanced to Rs.50,000/- each time (three times in life time) and above Rs.50,000/- will be reimbursed from SFMS.

Note:- The Employees/Pensioners who have already availed Medical facility ie., from General ceiling and Major ceiling, the same will be adjusted from the enhanced ceilings.

4. The enhanced General/Major/SFMS Ceiling limits comes into force with effect from the date of issue of this order. Further, the Employees/ Pensioners who have already availed medical facility prior to this order, the same will be adjusted from the enhanced ceilings.

5. This order shall come into force for the treatment taken on or after the date of issue of the order.

6. The other orders relating to existing medical scheme issued from time to time holds good.

7. This order is issued with the concurrence of Director (Finance) vide U.O.No. 84, dt.24.04.2023.
