The Telangana State Power Engineers Association would like to submit few lines for the consideration of Hon'ble Chairman & Managing Director/TSGENCO & TSTRANSCO and favorable orders please.

It is to submit that, vide ref(2) cited, TSGENCO management has issued Pay Revision 2018 orders to the employees of TS Power Utilities wherein it was mentioned that the HRA shall be allowed as per the rates in Government of Telangana.

Further, it is to inform that the TS Government, vide reference (1) cited, has issued orders on House Rent Allowance, with the rates of 24%, 17%, 13% & 11% based on certain classification of the cities and towns, without any ceiling limit and effecting from 01.04.2020. The orders were specifically marked to CMD/TSGENCO & CMD/TSTRANSCO also for taking necessary action.

As per the existing HRA rules in TS Power Utilities, the amount of HRA received by the employees, with ceiling limit of Rs.20,000/- per month is very less compared to the actual rent being paid, especially in Hyderabad and other major cities. Hence, it is necessary to adopt the new HRA rates on par with TS Govt. employees.

In view of the above, the Association requests the Hon'ble Chairman & Managing Director/TSGENCO & TSTRANSCO to arrange to revise HRA rates to the employees of TS Power Utilise as per the orders issued by Govt. of Telangana vide ref(1) cited above.
